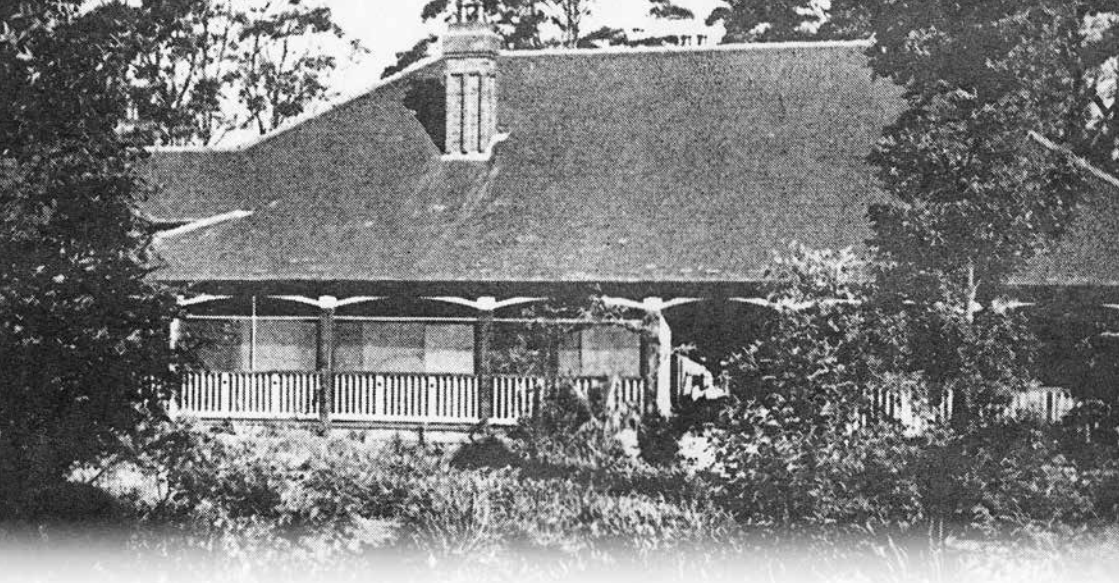
MISSION STATEMENT

HISTORY OF OUR GARDEN SHUL

It all began seventy seven years ago, in the year 1940. World War II was raging in its fiery path across Europe, and the Jewish families living across Sydney Harbour on the North Shore felt an urgent need to consolidate and belong to an established community. The seed was sown, and, after much organisation, the Northern Sydney Hebrew Congregation was born, holding its religious services in the Warringah Hall, 43 Yeo Street, Neutral Bay.

As the community grew, it stretched out to include Roseville, Lindfield and beyond, with services taking place in various private homes. As numbers increased, the need for a community centre became more pressing. Funds were duly raised and, in 1951, a large house was purchased in Treatts Road, Lindfield, to be known from then on as the 'Garden Synagogue'. And thus the Northern Sydney Hebrew Congregation found a new home and a new name -

The North Shore Synagogue.

A LEGACY MUST BE PRE-PLANNED

With a planned legacy, you can designate The North Shore Synagogue as the direct beneficiary of specific assets, or a portion of your Estate, or the residue of your Estate after payment of other commitments.

1. BEGIN WITH YOUR VISION

Although creating a Jewish Legacy involves a future gift in your Will or estate plan, it starts with your personal vision.

Think about what is most important to you, where your values lie and how you wish to contribute to a future Jewish environment.

Discuss your ideas with family and a trusted financial advisor and/or solicitor.

2. DECLARE YOUR INTENT

Having now made that decision, with help from your solicitor you may wish to notify The North Shore Synagogue of your intent.

Legacy

A legacy is a gift of a specified sum of money.

Residuary gift

A Residuary Gift is a gift of all or part of your estate.

I give, devise and bequeath all the rest and residue of my Estate of whatsoever kind and wheresoever situate to The North Shore Synagogue ABN 75 000 115499 of 15 Treatts Road Lindfield NSW 2070 for general purposes. The receipt of the secretary, treasurer or other officer of the Synagogue will be a good and sufficient discharge to my Executors.

A specific gift

A specific gift is a gift of a specific asset.

I give, devise and bequeath my property known as free of mortgage and charge to The North Shore Synagogue ABN 75 000 115499 of 15 Treatts Road Lindfield NSW 2070 for general purposes. The receipt of the secretary, treasurer or other officer of the Synagogue will be a good and sufficient discharge to my Executors.
